The Department of Education and Training is collecting your personal information on this form in order to obtain consent for disclosure of a student's personal information (see below) to facilitate registration and use of third party web based software identified on the form. The information will be used and disclosed by authorised school employees for the purposes outlined on the form.

Student personal information collected on this form may also be used or disclosed to third parties where authorised or required by law. This information will be stored securely. If you wish to access or correct any of the personal student information on this form or discuss how it has been dealt with, please contact your student's school in the first instance.

Dear Families

The use of web based educational resources has risen steadily over the last decade and are increasingly being used by teachers across Queensland to improve student learning outcomes.

At Noosaville State School, we have been using the listed programs for several years. Due to the Department of Education policy, we now need to have written Third Party Website consent.

Our school and teachers make decisions about the best technology to meet the needs of our students. Sometimes it is beneficial for students to utilize services provided by Third Party Web based providers.

Noosaville State School wishes to utilize the Third Party Web based service provider/s listed below to aid student learning. For your student to use the service, the teacher will need to register them as a user. Registering with these providers requires student school personal information to be disclosed to the provider of the service.

In the case of the services outlined on the next page, they are private companies that are hosted onshore in Australia and/or outside of Australia. Outside of Australia means that data that is entered to register for these sites, will be stored on servers that are not based in Australia and therefore are not bound by Queensland's privacy laws. Registration may include disclosing the following information about your student -:

- Student Name;
- Student ID;
- Year group;
- Class Teacher.

We need your permission for the registration and use of the sites by your child. These sites are listed on the following page.

Note: It is not compulsory for you to provide this consent – If you decide not to provide consent, this will not adversely affect academic achievement, or any relationships with teachers or the school. However in the future home access to Reading Eggs, Mathletics and Scratch by students will no longer be available from home without your consent. Lego Mindstorm is a program used in robotics during school time.
